


# **Annual Impact Report 2015**



## A LETTER FROM OUR CHIEF EXECUTIVE OFFICER



2015 was an extraordinary year at Clínica Tepeyac, punctuated with several momentous achievements. As one of Metro Denver's only health resources founded to serve uninsured Latinos, Clínica Tepeyac's ultimate goal is to help the most vulnerable members of our community achieve good health. With your help, Clínica Tepeyac made remarkable progress in 2015 towards achieving this goal.

In the early part of 2015, we completed a major expansion and renovation of the clinic, significantly increasing our capacity to serve more patients. As part of this expansion, we added a dedicated counseling room to create opportunities for "warm hand-offs" between our medical providers and behavioral health therapists. We also added a financial screening room to enroll Medicaid and Medicare patients, and a group visit room. We completed 12,092 patient appointments and served 4,897 unduplicated patients. Additionally, we made

9,940 health promotions and education contacts with 2,887 patients and community members.

In August, Clínica Tepeyac achieved a critical benchmark when it obtained its designation as a Federally Qualified Health Center (FQHC). FQHC status is reserved for clinics that have a demonstrated track record of providing comprehensive health services to underserved communities. Moreover, FQHC designation greatly enhances Clínica Tepeyac's prospects for long-term sustainability through general operating support, enhanced Medicaid reimbursement, and access to a discounted pharmacy program and other Federal grant opportunities.

Deepening the integration within primary care, behavioral health and health promotion continues to be a high priority for Clínica Tepeyac. Our behavioral health staff are present at the medical clinic every day to meet with patients and provide brief therapeutic interventions. Our health promotors "promotoras", are in the waiting room at the clinic most days to outreach to patients and invite them to participate in our wide range of health promotion and chronic disease management classes.

Clínica Tepeyac continues to prioritize expanding access to care; strengthening the integration among primary care, behavioral health, and health promotion services; and building upon our financial sustainability. We are also seeking feedback from our patients, neighbors and community stakeholders to help shape our long-term vision of bringing all of our services under one roof, while also adding oral health and pharmacy services.

We wouldn't be able to do all of this without YOU, our supporters. Many thanks to those who offer their time and resources in support of our mission to provide culturally-competent health care and preventive health services for the medically underserved.

## ABOUT CLÍNICA TEPEYAC

#### **NEED:**

Denver's most vulnerable residents often arrive at Clínica Tepeyac acutely ill, coming as a last resort after having delayed care. Between 80 and 90 percent lack any type of insurance. Even with expanded coverage through the Affordable Care Act, in the City and County of Denver alone there are nearly 90,000 low-income persons who are not being served by a health center.

### **MISSION:**

Clínica Tepeyac provides culturally competent health care and preventative health services to the medically underserved in metro Denver.

### **VISION:**

By 2020, Clínica Tepeyac is under one roof, tripling the number of visits completed annually while adding dental and pharmacy services.

#### **VALUES:**

Dignity ~ We respect the inherent dignity of each person. Integrity ~ We value authenticity and consistency. Quality ~ We demonstrate excellence.

- **12,092** appointments completed (913 of which were behavioral health visits).

## CLÍNICA TEPEYAC'S HISTORY

In 1993, parishioners of a church in north Denver noticed a growing number of Latino families who lacked insurance and were going without health care. The group conducted a community needs assessment and confirmed that a large percentage of the predominantly Latino community lacked health insurance and were more likely to be at risk of preventable illnesses. In response, community members transformed a dilapidated house next to the church into Clínica Tepeyac. In 1994, Clínica Tepeyac opened with two exam rooms and a culturally responsive staff and volunteers who, along with providing basic medical services, offered preventive health education. There has been tremendous organizational growth and evolution since, with the most significant being the integration of physical health, behavioral health and health education. In 2015, Clínica Tepeyac was awarded designation as a Federally Qualified Health Center (FQHC)—one of its most notable achievements to date and recognition of its ability to provide high-quality care for the underserved.


Where We Are (Clinic)




Where We Are (Administration and Behavioral Health))


## WHO WE SERVE

Clínica Tepeyac is a Federally Qualified Health Center located in the low-income Globeville-Elyria-Swansea neighborhood of Denver, Colorado. For more than two decades, Clínica Tepeyac has been providing affordable, accessible, culturally responsive health care for working poor, predominantly Spanish-speaking families and individuals in the Denver Metro area.

This map shows Clínica Tepeyac's patients in 2015 in relation to their home address. Although the clinic is located in North Denver, our impact area is throughout the entire Denver-Metro area. The clinic is located just north-east of the I-25 / I-70 interchange (represented by the green star on the map).

## CLÍNICA'S TEPEYAC SERVICES

• **PHYSICAL HEALTH:** Preventive care, primary care, chronic disease management, personal health coaching, HIV/AIDS managed care, referrals for specialty care and screening for enrollment in Medicaid.

Clínica Tepeyac provides low-cost primary and preventive care at its clinic. All paid clinic providers and staff who deliver services directly to patients are completely bilingual, and all volunteer providers possess some level of Spanish fluency. In addition to general primary care services, patients have access to a number of high-quality, evidence-based programs to support their health and wellness, including: comprehensive prenatal care for expectant mothers; HIV/AIDS managed care that is overseen by one of Colorado's leading infectious specialists; and a comprehensive diabetes program that includes exercise, healthy eating instruction and personal health coaching

• **BEHAVIORAL HEALTH:** Bilingual behavioral health services including counseling for individuals, couples and families, and both shorter interventions and longer-term treatment plans.

Physical health care is integrated with behavioral health care. Clínica Tepeyac has bilingual counselors who are available to respond when individuals and families are experiencing emotional distress. Clínica Tepeyac's providers are aware of the stressful challenges their patients face as well as the strengths of their patients' culture (resilience, spiritual beliefs, family and community) that empower them to move past those challenges.

• **HEALTH PROMOTIONS:** Cancer education and prevention, community outreach and engagement, smoking cessation education and advocacy, healthy cooking classes and exercise classes.

Health promotions, the third component of the integrated model, trains members of the local community to serve as peer-to-peer educators under the evidence-based Promotora de Salud model. Promotoras conduct bilingual, community-based workshops and provide one-on-one education and outreach to engage community members in their own health.

## A SUCCESS STORY!



Simon, a Latino male in his 50s, came into the clinic presenting with asthma. He works in a machine shop where he is regularly exposed to pulmonary irritants. As the primary provider for his family, Simon sought out care at Clínica Tepeyac because of our trusted reputation for culturally responsive service and affordability. Clínica Tepeyac's bilingual provider was able to treat his asthma; however, a blood test identified two other conditions —Simon was diagnosed with diabetes and dangerously high iron levels. Using the team-based approach, our providers helped Simon learn to manage his diabetes through medication, diet and exercise, and they immediately began treatment to steadily reduce his iron levels. Furthermore, through a longstanding community partnership, Simon was able to receive a low-cost biopsy on his liver to screen for other potential co-occurring conditions. The result is that Simon is breathing easier, managing his diabetes and is able to continue working and providing for his family.
